

Pepsi x Lay's x UEFA Champions League Sweepstakes & Instant Win 2021

Official Rules

NO PURCHASE OR PAYMENT NECESSARY. A PURCHASE OR PAYMENT OF ANY KIND WILL NOT INCREASE YOUR CHANCES OF WINNING. The Pepsi x Lay's x UEFA Champions League Sweepstakes & Instant Win 2021 (the "Sweepstakes") is a game of chance.

1. Eligibility

The Sweepstakes is open only to legal residents of Alaska, Arizona, California, Colorado, Hawaii, Idaho, Montana, New Mexico, Nevada, Oregon, Utah, Washington, Wyoming, the Territory of Guam and select Texas Zip Codes (see Appendix for eligible Zip Codes), who are 18 years of age or older at time of entry. The Sweepstakes begins on February 22, 2021 at 12:00:00AM Pacific Time ("PT") and ends on May 31, 2021 at 11:59:59PM ET (the "Sweepstakes Entry Period"). Administrator's computer is the official timekeeping device for the Sweepstakes.

4. How to Enter

During the Sweepstakes Entry Period, eligible entrants must visit a participating retailer, locate the signage advertising this Sweepstakes, and scan the code on the advertising. An entrant may center the code in the camera on their mobile device to scan. Once completed, the entrant will receive a link to a website. Once on the Website, an entrant must complete and submit the registration form including, but not limited to, his/her valid e-mail address, date of birth, zip code. You will receive one entry in the applicable grand prize sweepstakes pool, based on the code scanned by entrant, for this method of entry. There are 13 participating retailers for the Sweepstakes. Each participating retailer has its own grand prize pool as detailed below. Every time you enter in the Sweepstakes you will also receive one instant win play. To be entered into the drawing for a grand prize you must enter on or before May 9, 2021 at 11:59:59PM ET. Entries received after May 9, 2021 at 11:59:59PM ET will only be eligible to play for a chance to win instant win prizes.

Limit of one (1) sweepstakes entry and one (1) instant win play per person per day during the Promotion Period. You may only use one (1) email address to enter the Sweepstakes. Entrants may not share email addresses. Entries must be manually key-stroked by the entrant; use of automated entry devices or programs, or entries by third parties by any method of entry, are prohibited. Entries that do not conform to or that violate these Official Rules or are submitted in any manner other than stated in these Official Rules will be disqualified. Sponsor and Administrator will not be responsible for late, lost, incomplete or misdirected entries. Instant Prize Winners

Drawing Prize Winners

Potential winners will be notified approximately one (1) day after the drawing. 7. Verification of Potential Sweepstakes Winners
